# ANNUAL CONGREGATIONAL MEETING JANUARY 27, 2019 MINUTES AND AGENDA

#### A. MEETING CALLED TO ORDER

- 1. **Devotions Pastor Coleman** Said a prayer to open the meeting
- 2. **Declaration of a Quorum** Les Forbes More than 40 people were in attendance and therefore a quorum.
- 3. Appointment of a Secretary John Bartlett appointed.
- 4. **Appointment of Tellers** Bonnie Silvis, Stan Rose, Betty Pletz appointed by Les Fobes to serve as tellers for the Annual Meeting.
- 5. Motion to Adopt the Agenda –Ken Kraut moved to accept the agenda and Jan McInnes seconded the motion. Motion carried unanimously.
- 6. Report on Approval of the January 28, 2018 Annual Meeting Minutes Some people did not receive the minutes as requested via email.

### B. ELECTION OF COUNCIL, SYNOD ASSEMBLY DELEGATES AND ST. MATTHEW'S MERGER

1. **Nominating Committee Report** – Pastor Coleman – Greg Kern, John Tell and Pastor Coleman were in charge of the committee. This year we had a great response for the open council positions. There will be seven (7) council members elected, which brings the full number of council members to 16. LMC wanted to make sure that some members of St. Matthew's were on the council for the next term.

Names being put forward for vote – Vicky Blasco, Ken Kraut, Dorothy Overberg, John Tell, Pat Young, David Griswold, Michael Snider.

- 2. Nominations from the Floor Betty Pletz was nominated from the floor. However, Betty Pletz declined the nomination. There is a write-in area on the ballot for any nominations from the floor. Skip McInnes moved to close nominations and John Tell seconded the motion. Motion carried unanimously.
- 3. **Motion for Merger with St. Matthew's** RESOLVED, that the Plan of Merger between Luther Memorial Church and St. Matthew's Evangelical Lutheran Church of Erie, PA, in the form presented to this meeting, is hereby adopted, and the proper officers of the Church are hereby authorized to sign it and to take such other acts, including execution of other documents, as may be necessary to complete the merger.
- 4. **Synod Delegates** Stan Rose and Jack Tell are being nominated to attend the 2019 Synod. These names are on the ballot along with space for a write in.
- 5. **Ballot Distribution and Voting** Ballots were distributed and counted by Stan Rose and Charlie Lintelman.
- 6. **Announcement of Results** There were 94 votes that confirmed the nomination of the council members, the Synod delegates and the merger of the two congregations.

#### C. COMMENTS FROM LES FOBES AND PASTOR COLEMAN

Les Fobes – Les spoke about the hotel property prospective purchase. Les gave a history of the negotiations with the hotel owner which included the owner agreeing to the sell the property and then decided that he was not ready to follow through with the sale of the hotel property. Les spoke about some of the speculated reasons for withdrawing from the sale but did not completely rule out selling the property in the future.

Luther Memorial Church purchased the Thompson Building and the parking lot attached to it. To make the building function, an LLC was formed, Renew Erie, LLC, to manage the building. The committee to run the building is composed of Rick Kern, Greg Kern, Barbara Chaffee, Miriam Scheid and Les Fobes.

**Pastor Coleman** – The fifth floor room is in the process of being renovated for ReCharge and Luther Memorial Academy. The room was given in memory of Linda Collin and the room will provide space for all of us. There is Bluetooth technology that will allow the space to be used for many different events.

The Safety and Security Task Force run by Linda Graffius has been busy and Pastor thanked them for their vigilance. If a person is willing to be observant, or the eyes and ears, during the Sunday services, please let Linda or Pastor know that you are willing to volunteer during the church service. Volunteers will be given guidance and some training about what to look for during the services.

Pastor had the congregation turn to page 51 of the meeting agenda packet. He wants to make sure that the congregation is aware of the financial situation of the endowment that gives LMC a small cushion in the event of something unforeseen. Pastor also mentioned about the funds that were specifically relegated to property costs, the foundation fund. The Erie Community Foundation also holds a large amount of money that the church only draws interest from.

**Les Fobes** – Les wanted to make sure that the congregation was aware that the renovated room was also a music room that will be utilized by the school.

#### D. REFLECTION AND UPDATE ABOUT ST. MATTHEW'S LUTHERAN CHURCH

**Michael Snider** – We have felt welcome from the first moment we stepped through the door. Michael believes that the resurrection of the St. Matthew's Church with Luther Memorial Church has been the best decision the church had made. The budget committee for St. Matt's will be having their last meeting this month hopefully. Michael thanks LMC for the welcoming and integration of St. Matthew's into the merged congregation.

### REPORT OF THE CHURCH COUNCIL PRESIDENT

#### ANNUAL REPORT FOR 2019

As the year of 2019 drew to a close I thought about all that has taken place this year at Luther Memorial Church and Academy and the outreach that has affected our congregation and entire community. As a member of Church Council for many years, I have heard Rick Kern, Property Chairman, remind us of the structure that houses our congregation and school and of the unending maintenance and repairs that are required to keep a facility of this size and age operate smoothly. True to form, this year saw replacement of the emergency security lighting system, replacement of the fire alarm panel that monitors all detectors in the school and sanctuary, and new wall heathers in the school hallways. Perhaps the greatest challenge was redirecting traffic flow with the entrance changing to West 10<sup>th</sup> Street and the exits at the 11<sup>th</sup> Street side. Thankfully, there were no casualties and the system seems to be working well.

Parking has long been an issue on Sundays and at special events. To help alleviate some of the stress an agreement was reached with Berman Bedding so that guests and members may use their parking lots. Portable signs have been made and are working well to notify visitors of additional parking.

Renew Erie LLC (the old Thompson Building) was purchased last year at the time negotiations were being held concerning the hotel purchase. All units are rented and the management of this facility is going very smoothly. In the Treasurer's report you will see that a nice profit was realized this year. The management team is Rick Kern, Greg Kern, Ken Kraut, Barbara Chaffee, Miriam Scheid and Les Fobes.

Celebrations are always big events at Luther. This year marked the 15<sup>th</sup> anniversary of Pastor Coleman's ordination. This called for a special party planned by the Congregational Life Committee. Another celebration was held to mark the merger of Bethany Lutheran Church and St. Matthew's Lutheran Church with Luther Memorial. The 160<sup>th</sup> anniversary of Luther Memorial Church will be in 2021 – be prepared for some special things next year.

February marked the completion of the "Upper Room". This conversion of the fifth floor gathering space into a multi-purpose area serves as a new music room for Luther Memorial Academy, a permanent home for ReCharge worship services, a music practice area and an area for meetings, movies, and audio visual presentations, plus more. This project was made possible through Linda Collins' generous memorial contribution and is a memorial to her encouragement of the arts.

A Staff Relations Committee was formed this summer. Members are Diane Banks, Bob Banks, Becky Carullo, Lois Fobes, Les Fobes, Mark Lechner, Dorothy Overberg, and Lois Smith,. This committee is working with the staff to create new job descriptions for their positions. Once these have been completed and reviewed with the staff the committee is to meet with each staff member twice a year to review the job descriptions and then act as a liaison to Council about any issues that need to be addressed.

St. Matthew's blessed us with an endowment at the time of the merger. A portion of this money is in the "St. Matthew's Foundation". A committee of Casey Hedlund, Jean McMillen (chairman), Gina Sims, Michael Snider, Don Tatar, and John Vali has managed the fund this year. A portion of the funds will be distributed to outreach in our community. However, of significant difference is the "Member Outreach Ministry" (MOM). This ministry was established to provide financial support to individuals, families, or organizations where an urgent need is brought to the committee's attention by members of Luther Memorial. Members can request funds in any amount up to \$500.00. Many requests have already been filled.

#### Church Council President, cont'd.:

For the past two (2) years, the Emergency Task Force has been meeting to evaluate and plan for emergencies that might occur at Luther Memorial Church and Academy. Evacuation plans and security measures have been studied. Classroom locks and security shades for the classroom doors have been installed. Linda Graffius is the convener of this committee and it consists of representatives of the staff, school, church council and ushers. This past summer 14 representatives attended a workshop on church safety sponsored by Homeland Security and local police forces.

Again this year we hosted "Presque Isle ProMusica", an orchestra in residence at Luther Memorial Church. This year's presentations were "Summers Last Fiesta" and "Amahl and the Night Visitors". These events, as well as the Luther Memorial Concert Series and their presentation of the Bach Cantatas, have been well received by the Erie community. Thanks to Walt Gaber, our Cantor, choirs and musicians for beautiful music.

I would be remiss if I did not thank the entire Luther Memorial staff for their dedication to this ministry. I thank all of you who have served on committees, been Council members, prepared food, performed music, visited the shut-ins, prayed for all of us, knitted, led prayer groups and Bible studies, and all those other things that you do to make the mission and ministry at Luther Memorial an important part of the Erie community.

### REPORT OF THE PASTOR ANNUAL REPORT FOR 2019

The church is not a ship; it's a boat, and using the proper word matters for not only for sailors... but also for followers of Christ. A boat, for instance, is a favorite symbol for the church and some churches we have been a part of have a stained-glass window depicting a wooden vessel with a sail.

It's there to remind us of an ancient symbol for the church. Signifying a vessel of salvation, the boat was often used to portray the church. The old image still resonates in the word we use for the central portion of a sanctuary, the *nave*. The Latin word for ship is *navis*, and for boat, *navicula*. I think it must have been the latter -- a mere boat -- that the early church had in mind. But more than often the church acts like a cruise ship, and not a boat, and here is why that matters.

First, people who travel by cruise ship are passengers -- a very passive role. All the important decisions and all the work are handled by others, trained professionals called the crew. Ancient mariners on a boat, however, were not passengers; they *were* the crew. Raising sails. Tying knots. Pulling oars. If they didn't know how to do such tasks, they watched and learned from others. If they hoped to get anywhere, they had to share both the work and the decisions.

Second, passengers on a modern cruise ship all pretty much do their own thing. Some play shuffleboard, while others shop. Some stay in their rooms -- darn it, *cabins* -- and read, while others attend classes and lectures. Some swim, while others nap. On a boat, it's not like that. Raising sails and navigating by the stars takes not just work but teamwork. With no sonar or compass, ancient mariners carried ravens with them and released them into the sky. The crew would then assemble on deck (got it right that time!) and search the skies for signs of the black birds that would lead them to land. Ancient mariners had to learn to work together. Otherwise, they were -- quite literally -- sunk.

Third, passengers on a cruise ship dine at separate tables. They don't have to mix much unless they want to. On an ancient boat, everyone ate from a common table. They not only shared the food but worked together to prepare the meal and then clean up afterward. Mixing was not optional.

Fourth, modern passengers are entertained. In fact, the only mission of cruise ship passengers is to find ways to amuse themselves as they travel from port to port. They go to Broadway-style shows, watch movies or attend talks at the lecture hall, all in hopes of being entertained. Those aboard an ancient boat entertained themselves. When the day's work was done, they gathered together to share tall tales, true stories and bawdy jokes. How else could they get through all those long, dark nights as their boat drifted along?

Finally, fifth, it doesn't take much courage to sign up for a cruise. Typically, the gravest potential dangers are gaining 10 pounds from the buffet or twisting an ankle on the dance floor. In ancient days, however, the sea was terrifying. It was believed to be the one part of creation that had not been tamed by God. In an age when everyone believed in sea monsters and an earth so flat that you could sail right off the edge, it took guts to set sail in a creaky wooden boat. Ancient sailors had to trust in God and in each other.

Clearly getting the words right matters, and yet so often we do not always grasp the distinction between a ship and a boat. Sometimes, for instance, we act as though the pews were deck chairs, a comfortable place to sit and watch while others teach children, study Scripture, visit the sick and befriend the poor, but thankfully, the church is not a cruise ship. It is a boat where all can be transformed by working together.

Sometimes we divide into groups, with children, singles, young and old adults each sequestered and doing their own thing. Sunday school classes often share nothing more than a hallway. Conservatives huddle on the starboard side; liberals gather on the port.

Thankfully, the church is not a cruise ship, but it's a boat where all can be reconciled, trusting that our shared love of God is greater than our differences. Sometimes we forget that we are called not merely to coexist but to mix together in joyful fellowship. Thankfully, we share a common table of bread and cup, and there, we kneel together and receive from the same bounty of grace.

Sometimes we act like consumers in search of entertainment, shopping around for prayers, snappy tunes and comfortable messages. Thankfully, the church is a worshipping community united in purpose -- the glory of God. Volunteers come together to place the flowers, share the anthems and welcome guests, all with the understanding that in worship, we are not the audience -- God is.

And sometimes we take their vows of membership lightly, as though church were just a pleasant social club or an easy weekly routine. Thankfully, the church is a witnessing community, dedicated to making disciples -- and nobody can be a disciple without taking a few risks. Weekly, we remind each other that following Christ takes more faith, hope and love than any of us could muster on our own. When it comes to the church, it's not a ship; it's a boat.

I give thanks for the many ways Luther Memorial Church has acted like a boat during this year and has turned to the Lord in humility to direct our hearts into this form of authentic ministry. What we are doing here goes against our normal instincts, but through the gift of the Holy Spirit we are moved into lives of grace. My daily prayer is for the Holy Spirit to lead this congregation to follow the Lord's will, and my other daily prayer is that each person who is a part of this ministry may be moved by that same Spirit to minister more fully on this boat. Seeing our ministry as a "boat" ministry with all hands on deck is the only formula for the ministry growth we all desire.

Words cannot sufficiently express my gratitude to the church staff I am blessed to work with each day. I am very appreciative of them and the way we work together. I also want to give thanks for the faithful hands who transformed our 5<sup>th</sup> floor room and the giving of Linda Collin who made that possible. That was an important change for this ministry, because the 5<sup>th</sup> floor room is now used by our youth, council, LMA students, ReCharge worship, and choir. Thank you!!!

### REPORT OF THE PASTORAL ASSISTANT ANNUAL REPORT FOR 2019

As always, I must begin by thanking you for your continued support of the ministries of Holy Trinity Lutheran Church these past seven years. Your support enables this ministry site to continue to provide important outreach to the neighborhood of Little Italy, as well as to the wider community in the City of Erie. Your good wishes, thoughts and prayers are sustaining to both myself and your sisters and brothers in Christ at Holy Trinity.

Holy Trinity hosts the Tuesday evening Pasta Kitchen (serving 70-80 each week), the Soup Kitchen on Wednesdays (20-30 each day) and Saturdays at noon (40-50 each day); serving almost 7400 meals last year to the friends and neighbors in Little Italy. The Food Pantry is open on Tuesday evenings and provides an average of 35 bags of groceries each week, distributing over 1750 bags of groceries, and we have a Clothes Closet (gently used household goods and clothing) on Tuesday evenings, and at the Saturday Soup kitchens. The kitchen ministry was coordinated by a volunteer from Lamb of God Lutheran until August, at which point a group of volunteers and Denise and I took on the coordination efforts. It is a blessing as 98% of the people working in this food preparation ministry are from the wider ecumenical community, with the food pantry and clothes ministries being coordinated by Holy Trinity members. There is also a "Sloppy Joe" dinner the last Thursday of each month hosted by our sisters and brothers in Lutheran congregations throughout the city/suburbs (LM is there too in April, please come and join!).

We continued our efforts of developing and working through a mutual ministry program with McLane Church. Pr. Gary Harbaugh continues to coordinate with McLane and through these efforts, McLane provided gifts for each of our children under the age of 18, a "want' and a "need" gift was purchased for each of our 25 or so young people. McLane continues to publicize our ministries at their campuses, and we continue to get volunteers for the food ministries and other areas from their congregations.

In August we held our second annual Community Fair on Saturday, August 10, where we distributed 90 backpacks and school supplies to the students of Harding Elementary and the neighborhood young people. The parent teacher organization of Harding helped with the distribution and the administration from Harding was in attendance as well to answer any questions and assist with registration and provide information to the families as needed. We also provided a hot dog lunch, serving over 160 people lunch on that day as well. We had 200 backpacks and delivered the remaining 110 backpacks to Harding for distribution to their needy students. With the redistricting of the Erie School District, Harding is the elementary school for our area, so we are working to develop an ongoing relationship with the school, to inform their families about the ministries available at Holy Trinity and that they are welcome to participate.

In early December, Holy Trinity once again opened its door to the overflow shelter, "Our Neighbor's Place", now coordinated by the Erie United Methodist Alliance. Holy Trinity provided the space, and the two week stay, December 4-17, was led by the folks from EUMA, as Holy Trinity does not have the people to be able to staff the shelter.

On Saturday, December 7 the folks from LCBA Branch 49 most graciously brought a Christmas Party to the Saturday Soup Kitchen, and provided gifts, cookies, games and a visit with a jolly old elf for approximately 40 young people of the church and the neighborhood.

Through our food pantry, we were able to distribute 128 Walmart gift cards to the families served, providing a \$10 gift card for each registered family member for the Christmas Holidays.

Pr. Harbaugh has been working to strengthen our outreach in the areas of mission, and he has been working diligently with our sisters and brothers in the Sudanese community. Our Sudanese members offer their gifts to the ministry in many ways, but most especially in the form of singing, as they provide us with music from their heritage two to three times per month.

We added sixteen new members to our congregation this year through baptism and intake of members, mostly from within the Sudanese community.

Please know that the continuation of these ministries is a result of your vision and willingness to be the church in the world, and that the congregation truly appreciates your witness, and that you are welcome to visit any time the spirit would move you, and are always most obviously welcome to volunteer your time and talents in whatever way you are moved, as well.

And on a personal note, I do miss coming to Luther Memorial quarterly to lead and share in worship, but know you remain close in our hearts and thoughts and prayers. I cannot say it often enough, thank you again for your ongoing prayers, good wishes and support, and, peace and blessings to each and every one of you; in Christ,

After a period of several months, that congregation purchased a set of handbells more fitted to their needs and returned our Whitechapel bells to Luther Memorial. #### Cantor's Report, cont'd.:

The two existing electronic organs continue to provide reliable service with a few minor maintenance issues. It should be noted that, as with any electronic device, their lifetime is finite and we should prepare for their eventual decline or failure while maintaining them at their highest level. We also have a very fine grand piano in the nave which serves well as a solo instrument and for the accompaniment of instrumental and vocal music intended for the piano. The small pipe organ continues to provide valuable options for music in our worship. It has been used to accompany soloists and choral singing from the front of the church. Its ability to control the main electronic organ in the balcony via wireless MIDI (Musical Instrument Digital Interface) allows portions of our liturgy to be accompanied from its console at the front of the church – thus eliminating delays while the organist travels between the balcony and the front of the nave.

As part of the merger of the St. Matthew's congregation with Luther Memorial, we retained ownership of the 2-manual Rodgers electronic organ located in the St. Matthew's building. Upon the pending sale of that building to another organization, and after making a few necessary repairs to the instrument, we sought and found an interested buyer for the organ. The organ was moved to Holy Cross Episcopal in North East on January 11, 2020 and will soon be installed and voiced for that worship space. I have suggested that the proceeds of the sale be designated to establish an organ fund toward the eventual renovation and/or replacement of either of the Luther Memorial electronic organs when they reach that stage of their lifetime.

Kathy Sahlmann and Rose-Marie Rose have continued working with the children's choir. Throughout 2019, the children have sung in the 10:30 service – often on "pineapple" Sundays. Rose-Marie Rose has also provided solo vocal selections for the Blue Christmas service and funerals.

C. Noelle Partusch has regularly brought dance students from Mercyhurst to add liturgical dance to some of our services including processionals on Palm Sunday and Reformation Sunday. She also has interpreted the Lord's Prayer via dance. Her student and a member of Luther Memorial, Grace Petron, provided additional choreographic leadership for the Liturgical Dance Ensemble until completion of her degree at Mercyhurst at which time she moved to California to begin her career.

I thank those who serve on the Worship & Music committee, especially Cathie Dugan for her leadership and organization. The decisions and work of this group greatly contribute to the quality and completeness of our worship together.

Mark Lechner provides the weekly commentary in our bulletins for all the hymns that we sing. He suggested the addition of this feature a few years ago and has faithfully researched and written the notes that provide interesting background to poetry and music of each hymn. Every few months, someone mentions their appreciation of the background provided for the hymns we sing.

Our Concert Series continues to be the only one of its kind in the region. Its mission statement ends with "We believe art feeds the spirit." Committee members during 2019 include: Pat Bellingham, Molly Gaber, Brian Hubbard, Greg Kern and Mark Lechner.

I continue to serve as the Dean of the Erie chapter of the American Guild of Organists. This is a small group of organists, educators and fans of the organ who are part of a national organization that provides communication, education, performance opportunities and concerts in the realm of organ music. I am also a member of the NWPA ELCA Synod Worship & Music committee which meets several times during the year to plan and evaluate synod-wide worship services. I am also on the board of the newly-formed *Presque Isle ProMusica*, the chamber orchestra in residence at Luther Memorial (more detailed information may be found in the LM Concert Series report).


#### Cantor's Report, cont'd.:

### CARE AND HEALTH MINISTRY ANNUAL REPORT FOR 2019

Our Care and Health Ministry has be blessed and enriched in many ways during 2019. Our Care Ministers continue to be faithful in visiting our homebound members. Aging dynamics are changing and there are not as many people who are homebound so we have expanded our visiting to members who may still occasionally attend church but are getting older and frailer. We had 2 care recipients die in 2019. If you know of anyone who needs a visit, please contact myself or Norma in the church office. Or, if you would like to become a Care Minister, please contact me. We continue to loan out durable medical equipment, i.e. walkers, shower chairs etc., to members who need this equipment. Call the church if you are in need and Linda or Norma will help you obtain what you need.

The Magic Fingers Grace Group of wonderful crafters continues to grow in members and projects. They are making beautiful prayer shawls, prayer crosses, hats and mittens. The hats and mittens are given to the students at McKinley school and also to Bethany Outreach Center. Tiny hats and blankets are knitted for the NICU babies at UPMC-Hamot, and also taken to the oncology infusion center at UPMC-Hamot. Jan volunteers there and also provides the Word in Season devotion booklets. It warms our hearts that all of these items are helping others! She also takes these items to the VA hospital where they are much appreciated. Prayer shawls, knitted crosses and prayer stones are blessed at both services twice a year.

The OWL's, Older Wiser Lutheran group, continues to grow and enjoy each other's company. We gather for lunch at a restaurant or sometimes we have a lunch and program here at church. We had Karen Omniewski, the Public Health Dental Hygienist Practioner at the Erie Dept. of Health, present her program on taking care of our teeth as we age. In June we had Colonel Strong Vincent reenactor, Tom Hansen, present his very interesting story of the Colonel and his connection to Erie and Waterford. Other programs were a movie and lunch at the TREC facility and a scam and fraud program for seniors by Agent Alan McGill. We do not meet during Lent and are encouraged to attend the Lenten services and luncheons. In December OWL's and Magic Fingers combined for a delicious Christmas lunch, Walt led us in a carol sing, Skip Meyn played his clarinet and we played some games. We collected money from those in attendance and sent it the ELCA Good Gifts program to buy animals, help with clinical visits for children, etc. What a wonderful giving group of OWL's we have!

Many wonderful items were collected twice this year for the active duty military and residents at the VA hospital. Many boxes were sent overseas, and we received pictures and a flag from this platoon thanking us for our donations. What a wonderful outreach!

We have again experienced quite a few deaths of church members and care recipients. We reach out to the families by sending sympathy cards, Stephen Ministry grief books and cards to family members on the one year anniversary of their loved ones death. We held our 7<sup>th</sup> annual Blue Christmas service in December. This service included a healing anointing along with one other healing service during 2019. We also offer a blue bow in memory of their loved one from the beautiful memory Christmas tree.

Our prayer team continues to be very busy praying for our members and others who need our prayers. Linda and Jan continue as leaders of this group. We have many names on our public list and we have a private prayer list if you do not want your name on the public/bulletin list.

\*More than 860 households took advantage of programs at the center in 2019. Over 184 unduplicated volunteers gave 6,494 hours of their time to make a difference in the lives of those in need. In addition, we had an average of 51 volunteers per month who gave an average of 540 hours per month to IMPACT the lives of the families we serve at BOC 254.

### LMC PROPERTY COMMITTEE ANNUAL REPORT FOR 2019

As we have clicked off the years since the major renovation, now some 20 years ago, it has been long anticipated that everything virtually new at that time, would someday require replacement or significant repairs. The problem from a budgeting standpoint is that we can never accurately predict when equipment will finally quit working and a simple repair is no longer feasible. The year 2019 was one of those years. More simply put, 2019 was not a good year for LMC Property budgeting.

As part of a long-range plan for improvement of access to our facilities, LMC Council approved a plan to reverse the traffic flow through the parking lot, reconfigure the parking spaces, improve and add handicap parking, replace the concrete driveway entry ramp off 10<sup>th</sup> Street, replace sidewalk along the side of the church and replace the concrete entry on the East side of the school. As a stop gap measure, patching and sealing was performed on the parking lot rather than incur the extremely high cost of total pavement replacement which is planned to be done later in the long-range plan. The total expenditure for this multifaceted project was \$36,800.35. Just after Council approval of this project and the contracts for the work were awarded, multiple equipment failures occurred throughout our facilities – what timing!.

After struggling to keep the three commercial electric vestibule heaters working for several prior years, it was determined that the only solution was replacement. This happened this past summer – cost \$8,590.00. Also mid-season, we discovered that the two water coolers, also in the school, required replacement – cost \$2,850.00. And to complete our Property trifecta, just before school resumed, the emergency generator and transfer switch could not be repaired in a financially responsible manner so Council approved their replacement – cost \$7,885.00. Add to these costs an additional approximately \$9,906.00 for repairs to plumbing and heating units and \$2,135 for additional miscellaneous electrical repairs, all not anticipated. What a summer!

Fortunately, monies from the Foundation and a gift from the Morlin Company helped to defray the cost of the Parking Lot project and the generator replacement respectively.

The total costs of these four projects comprised 85.8% of the total spending on LMC Repairs and Maintenance.

On the LMC Services side, the costs were up 16% over 2018 to a total of \$27,456.02. The major costs were: Landscaping \$7,380.00, Cleaning \$5,309.00, Elevator \$4,199.24, Security \$2,484.22 and Snow Plowing & Mowing \$1,780.00.

Not to be forgotten in this past year, the "Upper Room" was completed in early 2019. Pastor Coleman's report will highlight all of the benefits of this project but suffice to say, this project has exceeded all expectations on usage and functionality. In conjunction with this project, the second floor front hallway bathroom was also renovated at a cost of \$3,921.18.

We all proud of the LMC facilities and the fine condition to which they are maintained. That said, our facilities will always need work and replacement of elements that are aging will be ongoing. All bequests and gifts to LMC for Property needs are so gratefully appreciated!

We are thankful to have Miriam Scheid, Dave & Norma Buerk, Charlie Lintelman, Les Fobes and many others that assisted with the Property needs this past year.

These BCV services involved the Luther Memorial choir and several choristers from throughout the community. We believe that this is a niche in the Erie music and worship community that is particularly apt for Luther Memorial. We are able to celebrate and present our heritage while providing a welcoming and worshipful setting for some of the greatest sacred music created.

The 2019 **Christmas Eve concerts** featured music for piano and organ performed by Walt Gaber. All selections were based on Christmas carols featured in "The Winter Rose" – the cantata presented during Advent and the two Christmas Eve services.

Most of our events have been enhanced by **post-concert receptions** hosted by several members of our congregation under the leadership of Les Fobes. These have encouraged fellowship beyond the performances and are greatly appreciated by the LMCS.

#### Concert Series, cont'd.:

#### **Presque Isle ProMusica**

When the Erie Chamber Orchestra was defunded in early 2018, several orchestra and community members intent upon the continuation of professional chamber orchestra music began work to create a new incarnation of that orchestra. The **Presque Isle ProMusica** was founded, incorporated and has acquired 501(c)(3) status as a non-profit organization such that it can accept donations that qualify as an IRS tax deduction for businesses and individuals.

Luther Memorial is playing a central role in this new orchestra by providing the venue for its concerts beginning in 2018. Musicians and audience members alike have often commented that Luther Memorial is the most fitting site for this size of orchestra due to our quality acoustics, seating capacity, central location and support of the musical arts in Erie. I serve on the board of directors and the Luther Memorial Concert Series will collaborate with this venture as their host – i.e. by providing a site for the orchestra's rehearsals and concerts at no cost to the fledgling orchestra.

The core group of people working to create this new ensemble was very appreciative when Luther Memorial offered to provide them with a home and venue at no cost to the orchestra - so much so, that it is known as the **Presque Isle ProMusica**, a chamber orchestra in residence at Luther Memorial Church. This continues our tradition of supporting the arts in the Erie community as an important part of our ministry to those around us. And it provides stability and community stature for the orchestra to be firmly associated with a well-known and permanent anchor in Erie. If you have any interest in assisting with this facet of the LM Concert Series ministry, please contact Walt Gaber. Recalling the LMCS byline (we believe art feeds the spirit), there are many ways you can help. We want to be the finest and most welcoming host we can as this orchestra establishes itself in the community.



Keep me safe, my God, for in you I take refuge. Psalm 16:1

One of the biggest challenges churches face today is to promote safety in the church, while still keeping it a welcoming congregation. We, as a team, are trying to keep everyone safe while still keeping the church open and welcoming.

The Emergency and Preparedness Team consists of ten members: Linda Graffius - Faith Community Nurse and Facilitator, Norma Buerk - Church Secretary, Miriam Scheid - Business Manager, Charlie Lintleman - Church Security, Chris Paul - LMA Administrator, Les Fobes - Council President, Jesse Graffius, John Steff, Barb Chaffee and Tom Klomp.

I would like to review our accomplishments for the church and school and then make you aware of some goals for 2020:

- Nine church members attended a Planning and Response for Houses of Worship presented by Millcreek Township Police and the Department of Homeland Security.
- A security curtain was placed on the nursery door and church office windows.
- We suggested that the church doors be locked 10 minutes after the service starts and this is now being done.
- Suggestions from our church insurance was obtained, reviewed and acted on as seen necessary.
- A walk-though of the building using checklists from Church Mutual Insurance Company was done and recommendations were made:
  - o New Fire Blankets were purchased for both kitchens and installed.
  - o Carbon Monoxide monitors were purchased and installed for the boiler room hallway.
  - o The emergency lights were inspected and updates were made.
  - The refrigerator motors, cooling coils and compressors will now be inspected and cleaned yearly.
  - o The securing of sacred objects, vessels and other valuables will be worked on in 2020.
- A floor plan for emergency exits was discussed and Bob Banks will start working on that in January 2020.
- All fire alarms, extinguishers and smoke detectors were inspected.
- Pastor gave a Temple Talk about security and the importance of volunteers. A sign up for "Safety Ministers" resulted in 9 people signing up. We need more!
- The need for outside security cameras was determined. Estimates were received and will be presented to council.
- Linda obtained a Disaster Plan from a fellow Parish Nurse at a Lutheran Church in Iowa. The team reviewed it and Linda and Norma will adapt it to our needs.
- Other downtown churches were contacted and only two have a safety team, St. Paul's Episcopal and St. Paul's UCC. We do have a working relationship with the security department at Select Specialty next door and their number is on the church office desk.

LMA, under the direction of Chris Paul, has been very proactive in updating the security at the school.

- Security curtains were purchased and placed on all the classroom door windows and office including the library.
- The teachers and ancillary staff participated in CPR, AED and Stop the Bleed training. They also went through the Active Shooter program. The State Trooper did a walk-through of the school building and identified needs and made suggestions for student safety.

#### Emergency & Preparedness, cont'd.:

- Drills will be done to practice the strategies that the Trooper suggested.
- Door jammers were purchased, but they didn't work as well as expected.
- The lockdown protocols from the Erie School District were obtained and these will be adapted to the needs of LMA.

#### Our goals for 2020 are:

- Provide opportunities for more people to sign up to be a Safety Minister.
- Provide Active Shooter training and have the State Trooper conduct a building walk through.
- Provide CPR-AED and Stop the Bleed training at least twice this year.
- Identify other members who already have these certifications.
- Contact the Fire Inspector to do a walk-through of the church.
- Contact Emergycare to determine if they want to visit our facility.
- Raise awareness with congregation members at all services on how to respond in an emergency.
- Complete a Disaster Response Plan for LMC.

## Benevolent Allocation Group (BAG) Annual Report for 2019

Our giving back to God through our gifts to others is an act of worship, an instance in which we are invited to give up something that we value as a sacrifice to God. Matthew 6:21 says: "Where your treasure is, there you heart will be also." We are invited to give our offerings to God because we want and need to give it. We have a spiritual need to worship God, and through our offerings we are able to express our love and devotion for God in a way that is simple and sincere. The motivation of the giver is what counts the most.

Our Giving is an Expression of Faith. The position of Scripture is that we *are* stewards, and it is not something we choose to be. God has chosen us to have dominion over all that God has made, to care for God's creation, while at the same time we are "a little lower" than God and the angels. BAG will create ways to more deeply connect Luther Memorial with those we serve.

Who serves in BAG and how is it structured? Stan Rose, Jack Tell, Diane Banks and Pastor Coleman serve on BAG. BAG determines how the recommendation to council will be made. The money tithed comes from money given to Luther Memorial Church which is unrestricted. This would **not** be money which would be assigned to annual budget income, but money given which has not been budgeted. Generally, the money assigned to BAG be would come from estate gifts. During the ministry year of 2019 we did not receive unrestricted money that would be eligible for a BAG distribution.

#### Greetings All!

Women of the ELCA in NWPA has once again been a force to behold! We continue to advocate in a variety of venues to promote our mission – Supporting, Engaging, Promoting, Empowering - whether it is volunteering at our own Bethany Outreach Center, helping with the refurbishment of the burned out Harmony Grove Lutheran Church, or sending financial support (\$631) to the hospital in Curran, Liberia for needed solar panels through our Sister Synod in NE Minnesota.

This past year has been a busy one, particularly in the area of social justice:

**SOAP** – we continue to be a formidable presence in Erie and surrounding areas. We have distributed more than 6000 bars of soap; we have reached out to approximately 30 hotels with materials and information regarding Human Trafficking in Erie County. I have spoken to many agencies in Erie and surrounding areas and started visiting teams in Clarion and Greenville. We participate in *Coalition Force* – *Erie*, collaborating with social service agencies, law enforcement, and education agencies.

**Lily Project** – Lori Perry has taken responsibility for keeping track of the medical facilities that are part of our gift bag program. We have outreach in Erie, Jamestown, Meadville, Oil City, Seneca, Franklin, Corry, Warren, and even in California and Iowa! With the possible change in the Crime Victim Center service plan, our bags can go directly to them.

**Bethany Outreach Center** – Not only do we send our financial support through Pennies for Poverty, but we have instituted W/ELCA Wednesdays. Some of our churches have volunteered to help at the Food Pantry distribution on Wednesday. We could use more help but we're hoping that we can continue to expand the idea throughout our Conference.

## Erie Lutheran Parish Annual Report for 2019



#### History of the Erie Lutheran Parish

From discussions between pastors in the city of Erie and congregational leaders plans began to discover ways to share congregational resources and partner with other Lutheran congregations in the city of Erie. Bishop Jones and Pastor Richard Schultz were active participants in the shaping of the vision and planning the emergence of Erie Lutheran Parish.

Foremost in the discussions and concepts were several goals. First of all is the affirmation of the ministries of each congregation. The ELP is to be seen as a means of support of these ministries. ELP has no desire to close or merge congregations.

Recognizing the challenges to congregations will call for different visions of leadership for congregations. This may include sharing pastors, utilization of certified lay worship leaders, T.E.E.M. personnel, and other skilled lay leaders.

During 2007, congregations were introduced to the vision and invited to be a part of the Erie Lutheran Parish. Articles of Agreement were completed and shared with congregations. On January 11, 2008, members of the congregations gathered in worship and signed the Articles of Agreement. The ministry has grown to include several task forces and several on-going ministries.

# REPORT OF THE TREASURER ANNUAL REPORT FOR 2019

At last year's annual meeting we adopted a budget with a \$16,323 deficit. We ended the year with a deficit of \$53,243. That's \$36,920 worse than expected. Here's what happened.

#### 2019 RESULTS

#### INCOME

**Total Income came in under budget by \$10,510.** Our total giving came in **under budget** by \$14,267; \$1,095 from pledged and \$12,715 from no pledge. Our investment income came in **over budget** by \$3,904.

#### **EXPENSES**

Our total expenses came in over budget by \$26,410.

#### **UTILITIES & TELEPHONE**

We were under budget in total utilities and telephone by \$5,222.

#### REPAIRS, MAINTENANCE & SERVICES FOR LM BUILDING

These line items were **over budget** by \$33,337. The parking lot repair was paid for out of the Foundation money. Special thanks go to Rick Kern, Dave Buerk, Charlie Lintelman and Miriam Scheid for taking care of our facility for us.

#### **SALARIES & STAFF SUPPORT**

These line items were under budget by \$246.

#### THE 2020 BUDGET PROJECTS A DEFICIT

We are expecting a deficit of \$43,149 in 2020.

We expect our 2020 total giving to be \$321,089. That's \$24,794 less that the 2019 budget and \$10,527 less the 2019 actual.

We increased the amount from Erie Community Foundation by \$2,200; a 2% increase.

We estimate our total expenses to be \$508,488. The estimated expenses are \$3,372 more than the 2019 budget and are \$23,038 less than the 2019 actual expenses.

The 2019 budget has a 2% increase for Pastor and staff and keeps their benefits at the same level as before. We have budgeted all expenses as close to 2019 actual expenses as possible with adjustments made as necessary.

The expenses are **not** the problem. The problem is the giving.

Our priorities are still new members. The evangelism and stewardship committees did a great job last year in getting additional commitments.

We have very good control of our expenses; it is the top two lines of the budget that drives this organization.
