Those Eligible to Vote per our Luther Memorial Church Constitution

Chapter 8 - Membership

Pastor

*C8.01. Members of this congregation shall be those baptized persons on the role of this congregation at the time that this constitution is adopted and those who are admitted thereafter and who have declared and maintain their membership in accordance with the provisions of this constitution and its bylaws.

*C8.02. Members shall be classified as follows:

- a. Baptized members are those persons who have been received by the Sacrament of Holy Baptism in this congregation, or, having been previously baptized in the name of the Triune God, have been received by certificate of transfer from other Lutheran congregations or by affirmation of faith.
- b. Confirmed members are baptized persons who have been confirmed in this congregation, those who have been received by adult baptism or by transfer as confirmed members from other Lutheran congregations, or baptized persons received by affirmation of faith.
- c. Voting members are confirmed members. Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have the privilege of voice and vote at every regular and special meeting of the congregation as well as the other rights and privileges ascribed to voting members by the provisions of this constitution and its bylaws. Process of Voting

If you prefer to email your vote(s), the hard copy ballot does not need to be returned, but be sure to type in the text of your email the information for a complete ballot.

If you have more than one eligible voter in a single household, you can write each name on the "name of voting members" line below. If you are each voting the same way, please mark "yes" or "no" one time, and each of your "yes" or "no" votes will be counted as an individual vote. If you have more than one eligible voter in a single household and you are voting differently, please be sure to communicate that to us on the ballot.
